Open to people aged 16 years or over whose main home is in the area defined by the Theydon Bois Parish Boundary, entitled to vote at a local government election in the Theydon Bois Polling District, interested in furthering the CIO's work and having paid any annual subscription laid down from time to time by the trustees of the CIO. The names of such individuals must be registered with the secretary of the CIO and are entitled to one vote.

MEMBER ORGANISATION

Open to a corporate body, or charitable incorporated organisation or an organisation which is not incorporated or any statutory authority in whose administrative area Theydon Bois lies, and interested in furthering the CIO's work and has paid any annual subscription laid down from time to time by the trustees of the CIO. Each member organisation shall appoint an individual to represent it and vote on its behalf at meetings of the CIO; and may appoint an alternate to replace its appointed representative at any meeting of the CIO if the appointed representative is unable to attend. The names of such appointed representatives must be registered with the secretary of the CIO. Member organizations are entitled to one vote.

JUNIOR MEMBERSHIP

Open to people aged under 16 years whose main home is in the area defined by the Theydon Bois Parish Boundary, interested in furthering the CIO's work and having paid any annual subscription laid down from time to time by the trustees of the CIO. They may attend General Meetings but shall not have the right to vote. The names of such individuals must be registered with the secretary of the CIO.

Liability of Members to Contribute to the Assets of the CIO if it is wound up - Every voting member of the CIO undertakes to contribute such amount as may be required (not exceeding £1) to the property of the CIO if it should be wound up. This would occur whilst he, she or it is a member or within one year after she, she or it ceases to be a member (for whatever reason) and would be used to cover payment of the CIO's debts and liabilities.
