## 8. To note the dates of the meetings of the main Council Meetings for the year ahead (as previously circulated)

Circulated and approved – next annual meeting date is provisionally set for May 26 2016 and the committee meetings as a whole will keep to the same layout as last year. All meetings to be open to the public.

#### 9. Correspondence - Clerk's Report

- > Re: Parking on Forest Drive. We had a meeting where NEPP representatives, Parish Clerk and Cllr Wood visited the site. Discussed ticketing for parked cars on the pavement NEPP don't have authority to ticket most cars there as it is unclear who owns that section of the pavement. (NEPP look at a standard pavement from the kerb and if the pavement changes/looks like it is not owned by Highways, they cannot ticket). They did suggest however that a potential way forward would be to put up pavement barriers to stop cars from parking there.
- ➤ Re: commuter parking on The Green. NEPP reps, Parish Clerk and Cllr Wood also visited residents on site. The residents were very upset that NEPP cannot offer a solution for the parking issues. NEPP explained that in most cases they aren't allowed to ticket the cars because of various reasons, eg no raised kerbs. Residents had thought this was more of a meeting about getting yellow lines on the Green and felt they had been misled it was explained that this is a Highways issue and residents are to bring a petition to PArish Office.
- Theydon Seniors summer party will take place on June 12<sup>th</sup>.
- > Donkey derby will take place on July 12<sup>th</sup>.

#### 10. Community Centre

10.1 No proposal as yet – we await both solicitors' feedback as they are close to conclusion on pre-emption rights: the wording is to be agreed soon.

# 19. Public Participation session – Open forum for members of the public to voice their views or make suggestions on any other Council Business or matters of local importance

- Resident commented on an increase in paved-over gardens in the village some look good but others don't. Suggested that Parish Council could encourage people to design thoughtfully if they want to do this. It could even be part of the Neighbourhood Plan. Cllr Gooch advised that we always look at landscaping issues from a planning perspective, as it's all part of the applications that are submitted to EFDC. Landscaping is usually under conditions for plans. Cllr Philip concurred that we could put references to this issue in the Neighbourhood Plan and that the Village Design Statement refers to front gardens. Rural Preservation should ask for conditions for landscaping when applications go in for new builds we can liaise with Nigel Richardson at EFDC on this score.
- Details about Cllr Philip needed for village website E Thomas to liaise on this matter.

- ➤ Resident asked if there are any new initiatives to be brought in by the Council in the year leading up to the next election. Cllr Philip said that this is active business and it's outside this meeting's remit to discuss it fully, but we have been mooting several new projects. If we attain Quality Council status we will have more scope but not till next year.
- If any residents do have suggestions, council; agreed that we're happy to listen. Discussed briefly initiatives that have taken place.
- Resident commented that many people in Theydon Bois don't know a great deal about the Parish Council; suggested an ideas box. Cllr Philip said that the Chairman's Column in the Village News outlined things that are going on, and the District Council surgery is advertised and would also be a point for information. People seem fairly contented but we find out if they are not. We await the Local Plan and its subsequent feedback later this year.
- ➤ Residents raised on-pavement parking issues in the village centre and beyond: traders have done this and now shoppers are following suit. Commented that it's dangerous, unsightly and there should be more clarity and control over what can and cannot happen. Cllr Philip noted that this has been covered earlier there are no regulations as to parking in this way, and NEPP are aware of the issue but it is not in their remit. Cllr Philip has discussed this with the Highways portfolio holder at EFDC so they are aware: legislation isn't very helpful and the situation is not ideal, but we will look into what we can do about it rather than what we can't. Suggested getting a surveyor from ECC Highways to see if we can use bollards and benches to create parking controls.
