Resident comment: Re. Highways – thank you for organising parking on the green. Suggestions for further considerations re.no-waiting regulations related to vehicles driving on the pavements as there is no room to pass with no-waiting rubric in place.

- 381.2 To consider and approve the membership of the agreed Committees for 2016-17: Agreed and new committee sheet (as it stands today Planning Committee substitutes and three positions are to be arranged). Cemetery Committee is to be amalgamated with Highways & Environment. New Committee for Neighbourhood Plan is in place. Highways & Environment is to cover CCTV Cllr Withers to lead, he and Cllr Philip to discuss.

384. Finance and General Purposes Committee

- 384.1 Approval of the Council's Accounts for the Year Ended 31st March 2016.Approved.Internal Audit report also OK. Cllr Philip observations: funds are up since last year, Section 106 money, to be spent on archive storage, is included in this. Youth & Community Trust and fencing disposal affects figure too. Borrowings are down.

 - 384.3 To note receipt (if received by next week) of the Internal Auditor's Report for the year 2015-2016 to be reviewed in the first instance by the Finance and General Purposes Committee

385. Planning Committee

385.1 Recent work of the Planning Committee covered in Annual Parish Meeting. Update on proposal for dog stud at Hill Road: Cllr Gooch escalated this to head of planning at EFDC and asked for criteria over change of use. Six dog rule usually triggers a planning application for change of use automatically – refer on case by case basis. More soon.

386. Highways and Environment Committee

- 386.1 Consultation on the Green: Cllr Purkiss described the unfolding scenario over the last 18 months regarding the constant stream of commuter parking. A petition led to a consultation and there is now a proposal to install yellow lines (Cllr Purkiss briefly explained where these will go and where spaces will be left the full proposal has been circulated). There is no perfect solution, and there are still issues to consider (including a school coach which picks up by the Baptist Church). The compromise, however, is acceptable and we will do the best we can with what we have. Parking for shopkeepers in the area is also important.
- Cllr Philip: we can't get double yellow lines on all sides, and not all of the houses have driveways.

 We can go to NEPP and suggest the scheme is reviewed properly once restrictions are in place.
- Cllr Purkiss: let's ask City of London to indent the lower end of the restricted zone: action: to write to the MP to ask City of London for an indentation.
- Cllr Philip: Action to write to NEPP and tell them to go ahead with the proposal and ask for evaluation of effectiveness after 6 months.

387. Community Liaison Committee

- 387.1 To note the next event for Theydon Seniors $10^{\rm th}$ June 2016. Guest appearance by Theydon Bois School Choir.
- 387.2 To note Christmas Market -2nd December 2016. Action: to write to City of London to ask formal permission to put the Christmas Tree on the Green. Must reserve the tree early.

388. Cemetery Committee

Amalgamated with Highways and Environment Committee.

389. Reports from Representatives

Cllr Wood: Buses –all new correct timetables are up at the stops, AW has distributed timetables she had delivered, as have the Office staff.

390. Any Other Urgent Business for report (without decision)

Please note that no decisions can be lawfully made under this item. The Local Government Act 1972 section 12 10 (2) (b) states that business must be specified; therefore the Council cannot lawfully raise matters for decision.

Cllr Philip: We have had two expressions of interest from prospective councillors to be co-opted. I will see them and let all Members know. If both agree we can publish details and the next stage will take place at next Full Council. Discussion to follow shortly.

Cllr Gooch: CCTV: there are ongoing queries about the system. Last meeting, we put forward £2000 for proposed funding: I have some costings and it is more than £2k. However this is a priority – a forum on this subject to follow, and the funding issue can be presented at Full Council. Cllrs Gooch & Withers to liaise via Highways Committee and report back at Full Council. Also please raise CCTV issue at EFDC.

Cllr Purkiss: Community orchard – there have been issues over ownership of land, and rights over land with ECC Highways. Suggested to talk to EFDC and bring the proposal to the next meeting: Cllr Philip will discuss with Alan Hall at EFDC.

Cllr Wood: BT phone exchange – the fence was broken: we are calling Maintenance.

Office Staff: reminder to all returning Councillors and information for all new Councillors: please let the Parish Office know if you will be absent from a meeting and copy that message to all councillors on the committee concerned.

391. Public Participation session – Open forum for members of the public to voice their views or make suggestions on any other Council Business or matters of local importance

Resident comment: parking on the Green – commuters are displaced on the grass side and many are illegally parked. Ideas of how to keep residents amenity were aired. School coach and coach trips from Baptist Church – suggested they use the bus stop on Piercing Hill as it would be safer. Resident has already spoken to City of London on this issue.

Resident comment: Single yellow line down Poplar Row: nobody ever goes there but the lower green is full of parking. Ambulances have problems there. Cllr Philip sympathised and assured that

the proposal in progress is a step in the right direction, we have also liaised with police inspector at Loughton and they will visit.
