511. To discuss & approve the Minutes of the Parish Council Meeting held on 18th May 2016

Cllr Burn said May 18 was a Wednesday not a Thursday. Otherwise approved and signed as a true record.

512. Roles and Responsibilities/Terms of Reference/Standing Orders

Cllr Philip encouraged councillors to undertake Code of Conduct training if they can – councillors should do the course once every term of office.

- 512.1 Terms of Reference of committees agreed. Finance & General Purposes Committee should discuss the Standing Orders and bring to Full Council. Cllr Burn pointed out changes to public participation rubric at Full Council –this will feature at Finance & General Purposes.
- 512.2 To consider and approve the membership of the agreed Committees for 2017-18: Agreed and new committee sheet circulated. Cemetery suggested to become standalone group again it needs to meet regularly. Suggested to have it on same night as Highways Committee but different personnel and agenda. Cllr Philip advised to look at terms of reference re. separating committees and bring it to full council.
- 512.3 To appoint representatives to External Bodies: agreed & list to be circulated. No notification of changes to Youth & Community Trust. Cllr Gooch was approached to be a rep: he is already a trustee. Cllr Philip propose Cllr Gooch as a rep and will find out if we should have two reps.

Donkey Derby: Cllr Howard will get a small gazebo for the stall from Ivan Pollock. The stall will be helpful to spread the word about what we do and to get more volunteers. Cllr Phillips to assist, Cllr Wood also. Asked if we would be allowed to display plans for Old School House and 16 String Jack – Cllr Philip said no, as they will be past their decision date on the day of the event. Cllrs Philip & Hannibal will be at the event and are happy to step in if people have queries about the Parish Council.

Christmas Tree: Still had problems with this last year - but we did have it on the green. To revisit soon.

520. Reports from Representatives

Buxton Trust: netting going ahead, installation from next Tuesday. We will then get the invoice and make the agreed contribution.

Buses: possible changes to the local service, halving its frequency. Cllr Philip will speak to new ECC councillor and key in Cllr Wood. Cllr Hannibal remarked that it is an excellent service and vital to the community.

521. Any Other Urgent Business for report (without decision). Please note that no decisions can be lawfully made under this item. The Local Government Act 1972 section 12 10 (2) (b) states that business must be specified; therefore the Council cannot lawfully raise matters for decision.

Cllr Burn: asked about amending a Standing Order to put public participation at the end of all full council meetings, if it is amended do we put the date of amendment in the new form of the standing order? It would make it clearer for new councillors to see when this was done. Also, if issues are brought to full council and there are councillors who might not be on the committees concerned, can we have information about threse issues in advance, including letters from individuals approaching the parish council and a short report so we can have background information and be able to ask appropriate questions.

Cllr Philip: this is a very good point.

Cllr Wood: any news from Highways on potholes? None.

522. Public Participation session – Open forum for members of the public to voice their views or make suggestions on any other Council Business or matters of local importance

Website: please send over dates for 2017-18, new committees and chairman's report. Cllr Philip cautioned that this will come in the next Chairman's Column in the village news magazine.

Village News: We now have Everything Epping Forest service on board. However the Village News/ Web Site need items direct and not just via the EEF media. Annual parish meeting and annual meeting of the council minutes need to be separate.

News desk: if the market is on December 8 we can't cover it as it will clash with our print schedule and delivery dates. Suggested that all Christmas market related material goes on the website.

The Limes: practice manager Debbie has been approached for an article in Village News but is unable to reciprocate as the new arrangements at the surgery are currently a trial only.
